ORDINANCE M-_____

AN ORDINANCE relating to the 2019-2020 Biennial Budget and making various appropriations in various funds; declaring an emergency.

BE IT ORDAINED BY THE CITY OF VANCOUVER:

Section 1. Supplemental appropriations are needed to meet certain necessary expenditures to be incurred in 2019-2020 which were not and could not reasonably have been foreseen at the time of adoption of the 2019-2020 Budget. As required by RCW 35.34.120, there is hereby set forth in summary form the total adjustments of expenditure appropriations for each separate fund adjusted and the aggregate totals for all such funds combined, as set forth in Attachment "A" of this ordinance. Attachment "C" outlines specific capital projects included in the 2019-2020 City of Vancouver Capital Budget.

Section 2. That a total of net 0.75 full-time equivalent positions are added as identified in Attachment "B" to this ordinance supported through grant funding. The position adjustments shall be made consistent with applicable civil service rules and personnel regulations.

Section 3. A separate City special revenue fund is created to account for revenues and expenses associated with the Affordable Housing Sales Tax Credit (RCW 82.14.540). The new fund is to be named "Affordable Housing Sales Tax Fund" (fund number 130).

Section 4. As reported in SR No. _______ the appropriations made in this ordinance are necessary to meet certain necessary expenditures that will be incurred in 2019-2020 which were not and could not reasonably have been foreseen at the time of adoption of the 2019-2020 Budget; an emergency is hereby declared, and this ordinance shall go into effect immediately upon final passage.
