## **Consent Agenda (Items 1-5)**

Council requested Items 2, 3, and 4 to be pulled.

### **1. Approval of Purchase and Sale Agreements to purchase 521 SE Chkalov Drive and 619 SE 116th Avenue and Related Agreements**

Staff Report: 130-22

*521 SE Chkalov Drive has been leased by the City since November 2019, and within the lease agreement, an Option to Purchase the property was included for an established price of \$10,460,500 if the City decided to exercise the Option. Within the agreement, a Right of First Refusal was included for the adjacent surplus property, located at 619 SE 116th Avenue, which is comprised of a parking lot. City staff has provided timely notice of*

*the City's intent to exercise the City's Option to Purchase 521 SE Chkalov Drive, a two-story, 44,500 square foot building. City staff has also negotiated the purchase of 619 SE 116th Avenue, designed as a parking lot.*

*City staff and representatives of the Owner have agreed that, subject to City Council ratification, the City will purchase 619 SE 116th Avenue for \$1,500,000. The purchase price for the surplus property is \$430,000 more than the appraised price, thus requiring review and consideration of Article VIII, sections 5 and 7, of the Washington Constitution, which restricts the City from giving or loaning public funds to private individuals, companies, or associations in order to prevent public funds from being used to benefit private interests where the public interest is not primarily served. Because the surplus property is strategically located adjacent to 521 SE Chkalov Drive, and thus serves to carry out a fundamental purpose of the City by providing growth support for public safety facilities, and because the purchase price is commensurate with reasonable market rate pricing and is being paid by the City without any donative intent, this difference in price and valuation does not constitute a gift of public funds or violate Article VIII, sections 5 and 7 of the Washington Constitution. (See, e.g., CLEAN v. State, 130 Wn.2d 782, 797, 928 P.2d 1054 (1996); In re Recall of Burnham, 194 Wn.2d 68, 77, 448 P.3d 747 (2019); and Brower v. State, 137 Wn.2d 44, 62, 969 P.2d 42 (1998).)*

*These transactions are intended to facilitate the relocation of the Vancouver Police Department's headquarters operations from their current location on 605 Evergreen Blvd, and serve as a permanent location of the Fire Department's Fire Marshal Office, as well as other city-related uses. Design documents are not yet finalized, but include plans for office space and training rooms. The adjacent property is strategically located to a public safety facility and provides additional space to accommodate future growth needs.*

- Request:
1. Authorize the City Manager or their designee to sign the Purchase and Sale Agreement to purchase 521 SE Chkalov Drive for \$10,460,500 plus related costs; and
  2. Authorize the City Manager or their designee to sign the Purchase and Sale Agreement to purchase 621 SE 116th Avenue for \$1,500,000 plus related costs; and
  3. Authorize the City Manager or their designee to sign all related agreements needed to facilitate the purchase of said properties on the terms referenced above.

## **Complete Streets - SE 34th Street Safety and Mobility Project**

Staff Report: 131-22

**A RESOLUTION** defining the Complete Streets process for analyzing opportunities to improve safety, equity, and mobility in coordination with upcoming pavement work on SE 34th Street, between 162nd and 192nd avenues.

*In November 2021 the City kicked off the SE 34th Street Safety and Mobility Project to analyze options for increasing multimodal access, safety and connectivity for all roadway users on SE 34th Street between 162nd and 192nd avenues. Today, SE 34th Street is a four-lane roadway that prioritizes auto travel. Between SE 192nd and SE 164th Avenues, there are no facilities for people biking. West of SE 164th Avenue, there is an on-street mobility lane in the westbound direction that connects people biking to SE 162nd Avenue, but eastbound bicyclists must use the vehicle travel lane. Sidewalks on both sides of the corridor provide space for people walking; however, sidewalks are located next to vehicle lanes where nearly 55 percent of drivers are going between 36 and 45 miles per hour (mph). This section of SE 34th Street also represents a large gap in the City's major east-west multi-modal corridor. Implementing complete streets facilities in this section will close this gap and better connect Downtown Vancouver to the eastside of the City.*

*The project is evaluating repurposing a travel lane in each direction to add dedicated space for people walking, biking, and using mobility devices, and other safety improvements for all users, including drivers.*

*In addition to the Complete Streets policy goals, several corridor specific goals have been identified for the SE 34th Street Project and are being used to align potential changes to the corridor with desired outcomes. The specific goals for the project are:*

- 1. Improve comfort and mobility for all users, regardless of how they choose to travel*
- 2. Prioritize safety for all users*
- 3. Make improvements quickly and efficiently*

### **Analysis Summary**

*To understand how repurposing a travel lane would change conditions for people driving on SE 34th Street, a traffic analysis has been completed for near-term (2022), mid-term (2027), and long-term (2040) scenarios. Traffic analysis findings indicate that under the near-term and mid-term scenarios, the project goals can be achieved without*

*substantially increasing travel time or delay experienced by people driving. Under the long-term scenario, improvements may be needed at SE 164th and SE 192nd Avenues to maintain continued safety at those intersections.*

### **Community Engagement Summary**

*There will be three main touchpoints to understand the community's use and concerns on SE 34th Street. In May 2022 and early September 2022, postcards and yard signs reached 10,000 households to learn about the project on Be Head Vancouver, take two surveys (on their use of the corridor and on safety design elements), and provide an opportunity for community members to share safety concerns. There will also be three focus groups in late September 2022 with neighborhood associations, schools, and developers to share about and hear their feedback on the project. The project team also attended community events like the Vancouver Farmers Market and Multicultural Resource Fair to share about the project and hear safety concerns on the corridor from the community.*

*Based on these findings, the project team proposes a design that will achieve the project goals of enhancing safety and mobility for all users while minimizing the increase in delay experienced by drivers where possible. The proposed design would provide one vehicle travel lane and a mobility lane with a buffer separating the two lanes in each direction.*

Request: Approve the resolution confirming the approach to proceed with design and outreach related to repurposing a travel lane on SE 34th St to increase safety and mobility for all users.

### **3. Fossil Fuel Code Changes**

Staff Report: 132-22

**AN ORDINANCE** relating to use and development standards for fossil fuel storage and handling facilities; amending various sections in Chapters 20.150, 20.160, 20.410, 20.420, 20.430, 20.440, 20.450, and 20.895 of the Vancouver Municipal Code; terminating the existing moratorium prohibiting the establishment of new, or expansion of existing, large-scale fossil fuel facilities, originally enacted by Ordinance No. M-4295 and most recently extended by Ordinance No. M-4370; and providing clauses for savings, severability, and an effective date.

*In June 2020, City Council enacted a six-month moratorium on new or expanded large-scale fossil fuel facilities, based on concerns about potential impacts to local public and environmental health and safety and to climate change. It has been enacted to allow time to update the land use code standards for such uses and to align them with other planning efforts currently underway, such as the Vancouver Strategic Plan update, Climate Action Plan, and other Title 20 code amendments. The moratorium was extended four times by the City Council and is currently scheduled to expire on November 6, 2022.*

*Over the past two years, staff has consulted with fossil fuel industry experts, and engaged in a series of meetings with environmental advocates and fuel industry stakeholders including the Port of Vancouver and numerous representatives from several existing bulk fuel facilities, as well as the Planning Commission and City Council. Planning staff have tried where possible to incorporate input on specific code language to make the ordinance clearer and to balance the stated objectives of the Council with industry and environmental perspectives.*

*Six large oil storage or transshipment facilities exist in the City of Vancouver, four within the Port of Vancouver, one further west at Tidewater Barge, and one near Fruit Valley Road. Five of the facilities are within the IH, Heavy Industrial District and one is within the IL, Light Industrial District. All are located within areas susceptible to liquefaction in the event of an earthquake. All are located within the Fruit Valley Neighborhood in a census tract is identified by the State Department of Health being vulnerable to adverse health outcomes from environmental exposure due to lower median incomes, higher percentage of persons below the poverty line, higher percentage of Hispanic and non-white residents, and lower education attainment. Fruit Valley may be disproportionately impacted by the proposed ordinance because it contains most of the heavy industrially-zoned land in the City and is adjacent to a major railroad line; however, the ordinance attempts to address these issues by providing for extensive public review of individual applications to site a cleaner fuel facility and attaching stringent development standards related to health, safety and environmental protection.*

*The proposed ordinance has the potential to improve safety of existing facilities through seismic upgrades, and any new facilities would be heavily scrutinized for potential environmental or neighborhood impacts. A major improvement is that the proposed ordinance would ban new bulk fossil fuel facilities, coal energy facilities and solid fuel storage uses that would have been allowed in the IH District. Existing bulk fossil fuel facilities would be allowed to convert to cleaner fuels with minimal process and, as an incentive to transition away from fossil fuels, could expand capacity by up to 15% provided the facility meets seismic codes and other standards.*

*New small fossil fuel facilities less than 60,000 gallons total would be allowed in the IH Heavy Industrial District as a conditional use, which requires a public hearing to consider specific impacts. New small cleaner fuel facilities less than 60,000 gallons total would be allowed as a limited use in the IH District, subject to administrative approval (no hearing). Both categories of small fuel facility uses would additionally be required to comply with an extensive list of development standards to reduce impacts, including:*

- *Minimum 1,000' buffer from residential zoning*
- *Construction to seismic standards; approval of fire response and spill control plans*
- *Greenhouse gas (GHG) emission study required*
- *Financial assurance in case of accident required*
- *Annual report to City regarding capacity, shipment activity/type required*
- *Permit oversight by the Southwest Washington Clean Air Agency and WA Department of Ecology*

*Following a public hearing on September 13, 2022, the Planning Commission voted 3-1 to recommend approval of the proposed ordinance to City Council.*

Request: Schedule the second reading and public hearing on the proposed amendments to VMC Title 20 regarding fossil fuel uses for October 3, 2022. Following the public hearing on October 3, approve the ordinance as proposed.

*Currently, all law enforcement recruits in Washington State, regardless of employing agency, must attend the basic law enforcement academy in Burien Washington to obtain their credential. This single academy approach results in insufficient training capacity, barriers to historically underrepresented candidates for employment, and delayed service to the community for newly hired police officer candidates as they await a training slot.*



Request: Approve as part of the consent agenda a resolution endorsing establishment of a regional criminal justice training center serving Vancouver and other communities of southwest Washington.

Dear Mayor McEnerney-Ogle, City Councilmembers and Staff,

Thank you for your multi-year effort to extend our moratorium on bulk fossil fuel infrastructure, and now turn our moratorium into a targeted, permanent ordinance at the second reading and public hearing on Oct. 3. I appreciate how complicated this policy effort has been. It has been a challenge to keep track of it, even from the outside.


I am thankful that the City is capping new bulk cleaner fuel facilities at 1 million gallons, and that conditional use permitting is required for them. And I am grateful that the City is requiring conditional use permitting for new small fossil fuel storage and handling facilities less than 60,000 gallons. It is important that the public has built-in opportunities to weigh in on what gets approved in the future, and what doesn't.

I am still concerned that there is nothing in this code that prevents smaller fossil fuel or clean fuel projects from aggregating in close proximity to one another. Multiple smaller fuel facilities could pose cumulative risks of explosion, leaks and emissions. While I am glad there is a 1,000 foot buffer zone between all these fuel projects and residences, I don't think that is a big enough distance to protect nearby residences from leaks or explosions, or emissions.

Overall, these code changes will help protect Vancouver's health and safety. The ordinance will be a big accomplishment for the City, and hopefully will help us reach our ambitious goals in the Climate Action Framework.

Thank you for your consideration, and for allowing for continued public input.

To Vancouver City Council,

I am writing regarding the city's new fossil fuel ordinance and urging support of residential energy code proposals especially regarding requirements for heat pump systems in new homes and stricter ventilation for gas stoves to protect indoor air quality and health.

As the climate crisis progresses, its impacts are increasingly felt here in Washington. In the past year alone we have seen the direct impacts of climate change in our droughts, wildfires, and heat waves which have cost hundreds of lives and had huge economic impacts across the state.

Buildings are the fast growing source of carbon emission in Washington State, with this increase largely attributable to the use of fossil gas in homes and buildings. In 2018 burning fossil fuels in buildings sector in Washington produced 18 million metric tons of carbon dioxide equivalent to the annual emissions from 3,957,182 cars or 5 coal plants. As such, Washington's 2021 State Energy Strategy found that electrifying buildings will be the lowest cost pathway to meeting the state's climate goals of reducing emissions 95% from 1990 levels by 2050.

Heat pumps will also help us get there. Moving to highly efficient heat pump technology can reduce energy use for heating and cooling homes, especially in comparison to outdated window air conditions units. As we continue to see peak temperatures rise in the Pacific Northwest, more and more people will need AC units, which heat pumps provide alongside heating to cope with heat related health impacts, or to adequately cool their homes while they are shut inside to wildfire smoke.

I urge the Vancouver City Council to adopt the new fuel ordinance in their September 26 meeting.
