Partnerships among our local agencies and with state and federal agencies are vital to the success of our efforts to reduce the number of violent and property crimes and to investigate the crimes that do occur. We also work closely with the community, involving citizen volunteers in many of our public service efforts. We seek to support and enhance the effectiveness of local law enforcement and the criminal justice system through planning and implementation of evidence-based strategies. JAG funding will be used to enhance community policing and problem-solving strategies to improve safety and quality of life for all our residents, businesses and visitors. It will provide our law enforcement agencies with much-needed funding for training, technology, and equipment to improve police leadership, operations, investigations and safety for police officers and the community we serve.

Program Narrative

The JAG Program allows states, tribes, and local governments to support a broad range of activities to prevent and control crime based on local needs and conditions. As a certified disparate jurisdiction, Clark County and the City of Vancouver, Washington propose to share the Fiscal Year 2021 JAG Local award totaling \$107,942.

Clark County and the City of Vancouver continue to work closely together to coordinate efforts involving JAG and related justice funds. As in other jurisdictions, local budgets are stretched, leaving many needs unfunded. A review of public safety priorities and criminal justice system needs in our community has led to the prioritization of the following programs.

Clark County will receive \$53,971 and the City of Vancouver will receive \$53,971 to make strategic investments in police equipment, training, and technology to address community safety and improve the criminal justice system and law enforcement operations.

Clark County and the City of Vancouver will use this JAG award to supplement and enhance existing state and local budgets, leveraging current resources to maximize the impact of our proposed programs and activities. We will not supplant or replace local budgets or non-federal funds appropriated for the same purpose.

Each participating agency will ensure that all drawdowns and grant expenditures are tracked separately from other funding sources and are compliant with federal, state, and local guidelines. Specific budget numbers and project codes will be assigned so that all expenditures and revenues under this grant can be precisely identified, tracked, and reported to the grant agency.

Grant funds will help us to enhance the effectiveness of the criminal justice system by supporting areas of national focus and priority, while helping to integrate evidence-based and proven practices into our everyday work. The funds will help local law enforcement to maximize use of existing resources and to target emerging and chronic crime problems. Our agencies share the goal of preventing violent crimes, in order to save lives and reduce the burdens on courts, corrections, the justice system, and our community as a whole.

Project activities will be completed within the four-year federal funding period. In addition to collecting data for federal performance measures and reporting requirements, Clark County and the City of Vancouver will also assess how well grant objectives are being met. We will document supported activities for each reporting period and will evaluate the progress our local government agencies are making toward the Department of Justice's key mission - reducing and preventing crime and violence.

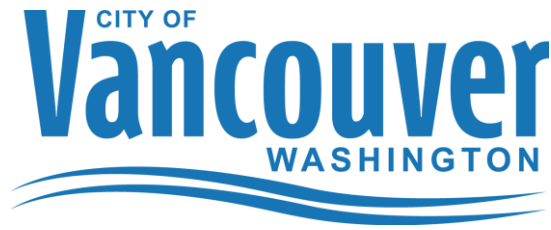

The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and local governments to support a broad range of activities to prevent and control crime and to improve the criminal justice system, some of which could have environmental impacts.
