AMENDMENT TO MASTER PRICE AGREEMENT


1. **Product Addition.** Attachment A to the Master Price Agreement shall be amended in part to reflect the following product addition:





ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, National Purchasing Partners (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
