**SUBJECT** Continued Use of Washington State Contract 05916 for vehicle purchases

# **Key Points**

- The City has greatly benefited by using Washington State Contract #05916 for the purchase of Chevrolet, Dodge, and Ford vehicles from Northsound Dwayne Lane (Dodge Dealership), and Columbia Ford. The City wishes to include Bud Clary Chevrolet in this arrangement.
- This contract does not expire until 1/5/2021 and can be extended an additional five years.
- The city has reached the limits of expenditures approved by Council in 2017.
- This contract is competitively bid.

### **Strategic Plan Alignment**

### **Present Situation**

The City uses Washington State Contract #05916 for vehicle purchases such as police vehicles, light duty vehicles, and medium duty vehicles.

Equipment Services would like authorization to continue to use the contract to purchase up to the Council-approved annual budgeted amount for vehicle purchases through the end of the contract, which is 1/5/2021, and into any extended period offered by the State of Washington.

The City has purchased up to the approved levels authorized by Council in 2017 and requests authority to continue to purchase using this contract up to the amounts approved by Council in City's budget process.

### Advantage(s)

- 1. Currently, the City purchases vehicles through the Washington State Contract that match the current City of Vancouver standard vehicle platforms. This helps with continuity of the fleet vehicles and the ease of purchase for maintenance required parts.
- 2. The vendors covered under this contract have continuously provided high quality; dependable vehicles that help maintain uniformity in the City fleet and the operational needs of many of the various departments.
- 3. The approval for continued use of this contract will enable Equipment Services to order the required fleet replacement vehicles while taking advantage of the Washington State contract's competitive pricing.

# **Budget Impact**

- Utilizes an existing contract thru Washington State that is good thru January 5, 2021, with an option to extend through January 5, 2025, and/or their replacement contract number, which is valid through the same timeline.
